# ELIGIBILITY CRITERIA FOR OFFICERS/OFFICIALS

7.

- All Civilian Federal/Provincial (Government of Baluchistan) Government Officers/officials, cadre and ex-Cadre Officers/officials are eligible. 1.1
- Only those Federal / Provincial Government & ex-Cadre Officers/officials are eligible for allotment in Saryab Road Quetta project who have regi 1.2
- Regular BPS shall be considered as on the cutoff date of depositing down payment for the allotment.
- 1.3 The eligible Officers/officials will be allotted house after balloting of house number. This offer will also stand valid to the legal heirs of the succi 1.4
- An officer/official will be entitled to only one housing unit from PHAF. 1.5

#### INELIGIBILITY CRITERIA FOR OFFICERS/OFFICIALS

- 2.1 The pay scale of selection grade, acting charge, adhoc, contract appointment is ineligible.
- 2.2 The Officers/officials who have been dismissed from the Government service on disciplinary grounds are ineligible.
- 2.3 Resignation or retirement of Officers/officials without terminal benefits makes them ineligible for allotment.
- Federal/ Provincial Government Officers/officials who have been allotted any house/ apartment under PM's scheme as Provincial Government 2.4. off, shall be ineligible.
- 2.5 Contract, adhoc or contingent pay scale / staff employees shall be ineligible.
- 2.6 Officers/officials who do not possess membership are ineligible.

#### ALLOTMENT OF HOUSING UNIT

3.1. Allotment letters shall be issued to allotees in due course of time after depositing down payment of housing unit.

#### CANCELLATION OF ALLOTMENT

- Allotment shall be processed for cancellation in case the applicant does not deposit the 5% down payment of house price within specific time gi 4.1
- The allottee at any stage can opt for cancellation of his/her allotment subject to deduction of cancellation charges i.e. 10% of deposited amount 4.2
- 4.3. Allotment shall be processed for cancellation in case of non-payment of 3 consecutive installments.
- Cancellation notices will be issued after the default of three quarterly installments and after the issuance of third notice, allotment will be proce 44 the given date of the third and final notice.
- Cancellation notices will include notice through letter on the address provided by the applicant. It shall be the responsibility of the allottee to 4.5. PHA Foundation will not be held responsible for non-communication of any kind.
- 4.6. PHA Foundation shall have the right to either retain or dispose of the cancelled housing unit, as per policy.
- If any personal information regarding service is proved wrong at any stage after allotment, PHA Foundation reserves the right to cancel the allotment 4.7.
- In case of cancellation due to non-payment of installments the deposited amount shall be refunded after deduction of 10% deposited amount 4.8. auctioned/sold in open market.
- 49 Allotment shall stand cancel in case of any violation of PHA community by-laws.
- 4.10 Allotment be processed for cancellation in case an allottee does not take possession of the housing unit up to six months of formal offer of the air the allotment will be processed for cancellation.

## COST OF HOUSE

- The tentative costs are subject to variations on account of escalation in prices and unforeseen circumstances. The cost of housing unit, if increases 5.1. determined and charged from the allottees on the basis of actual expenditures incurred on completion of the housing unit which will be combulletin shall be charged/recovered either during execution/currency of the project or at the time of handing over of possession as PHA Foundat
- The allottees shall be required to bear, if in case required in future, the increase in expenses on account of consultancy charges and any unforest 5.2 overheads etc., including the expenditure on account of the establishment / service charges of PHA Foundation as may finally be determined and
- The one time or recurring charges / expenditures on account of individual external water, electric and gas connections and other services shall be 53
- Statuary taxes/duties as per law of the land shall be applicable. 5.4

## PAYMENT SCHEDULE

- 5% amount will be deposited as down payment with application form along with non-refundable enlistment / processing fee of Rs. 15.000/- for 6.1
- The applicant will have to deposit down payment within given date of issuance of offer letter. In case the applicant does not deposit the requis 6.2 cancellation
- Remaining 95% of housing unit price will be payable in 5% at the time commencement of work at the site, 5 balloon payments @ 5% each by the 6.3 quarterly installments.
- Rebate of 2.5% shall be allowed in case the applicant after balloting deposits 50% of housing unit price and 5% in case of payment upto 100% of 6.4.
- The allottees are bound to pay all other charges, including unprecedented escalation, bank charges, stamp duties, reserve fund, statutory levies, 6.5
- The payment schedule, indicating the date and amount, by which the payment is required to be made, will be communicated in the offer letter 6.6. Payment Charges @ 1% of the installment amount.
- Requisite upfront payment along with the duly filled application form will be submitted in PHA Foundation head office by the member. 6.7.

- No call up notices / reminders will be issued to allottees for payment of installments, hence allottees are requested to adhere to the installments 6 10

# IMPORTANT GUIDELINES FOR ALLOTTEES

- All open areas within the project premises shall remain the property of PHA Foundation all times and the PHAF (or its authorized entity) reserves 7.1 restricted to the house premises.
- 7.2 No allottee shall have the right to make construction outside his / her housing unit including parking sheds or projections etc.
- From the day of PHA Foundation's formal offer for possession to all its allottees, minor defects of the housing unit shall be repaired free of co-7.3 period shall not be extended to those allottees who do not take possession after PHA Foundation's offer for taking over possession. Day to day will be the responsibility of the allottees.
- In case, the allottee does not take possession of housing unit within One (1) year after the possession offered the PHA-F reserves the right to retain 7.4. have no right to claim the market price of the house at that time.
- Housing unit shall only be used for residential purposes and in no case, whatsoever can be used for any other purpose. 7.5
- The respective allottees or occupants shall abide by the existing by-laws / rules / terms and conditions of the concerned local authorities and PH 7.6 Delayed payment charges are levied @ 1 % per month for late payment of installment (for exact No. of days). Waiver of delayed payment char 7.7.

- No bank profit will be paid for early payment of installments 7.8
- No bank profit / rent will be paid if the project is delayed due to any reason. 7.9
- No bank profit / markup is payable to allottee in case of withdrawal of the scheme due to any reason. 7.10
- All the correspondence will be made on the mailing address of the applicant mentioned in the application form. Allottees are requested to int 7.11 Foundation will not be held responsible for non-communication of any kind.
- PHA Foundation shall send the letters to the parent department of the applicants regarding verification of the service status which is provided by the applicant. However, till the verification letter is received from the 7.12 department, Provisional allotment letter will not be issued.
