Farooq Khan Sherwani, Director Engineering against PHA, on the operation/implementation of the decisions taken in the subject meeting, the BoD directed that the matter may be kept pending till judgment from the relevant court is received.

Now, the honourable court has vacated the stay orders, therefore, the Board may confirm the minutes of 4th BoD meeting.

5th BoD Minutes of the Meeting

The Managing Director/ Chief Executive Officer, PHA Foundation briefed the Board and stated that minutes of previous meeting held on **08**-03-2012 were circulated among the members. However, no objection has been raised/received, therefore, the Board may confirm the minutes of the 5th BoD meeting.

The Board Confirmed the minutes of 4th & 5th BoD meetings.

ALLOTMENT OF HOUSING UNIT IN CAT-I AT KURRI ROAD ISLAMABAD

It is briefly stated that inauguration of Kurri Road Housing Scheme was held on 9th of Feb, 2012 by honourable Prime Minister of Pakistan. First meeting of board of directors in which following decision was taken;

> "The eligibility Criteria for the allotment of housing unit into category I, II & III be extended to all Federal Government officers of BPS(20-22) including ex-cadre officers and allotment be made on "first come first serve basis"

2. On 28/05/2012 Mr. Fazal ur Rehman, Chief Secretary Sindh (Retd) deposited Rs. 500,000/-. Due to this part payment a housing unit was reserved for him. Later on he further deposited Rs. 1,000,000.

3. Meanwhile, Mr. Iftikhar Rashid, a BPS 22 officer, submitted an application for allotment of housing unit in Cat – I

### **Decision**

The Board discussed this item in detail and after thorough deliberations, the Board decided that the request of above mentioned officers may be regretted and the amount paid, if any, may be refunded.

Agenda Item No. 4

#### WAIVER OF DELAYED CHARGES

The matter of waiver of delayed charges has been discussed in the 5th meeting of Board of Directors and it was resolved that "The BoD approved the proposal in principal. However it was also decided that PHA Foundation may work out the details for implementation of the proposal. The BoD further directed that PHA Foundation may make a presentation to the stake holders so, that their views are incorporated in the proposed arrangement".

As per decision of the BoD, PHA Foundation has conducted meetings with allottee's associations of the concerned projects, and representatives of allottees have not only demand 100% waiver of delayed payment charges but have also claimed compensation owing to delay in completion of the projects. Some of the allottees have also approached courts and P.M secretariat in this regard.

Summary of the projects launched and current status of completion (provided by the Engineering Wing) is stated below:



In light of the above the following proposals/options are submitted for consideration of the Board:

- i. Delayed payment charges may be completely waived off where the completion of the projects is delayed.
- ii. 50% waiver in delayed charges may be allowed where projects are delayed.
- iii. The waiver of delayed payment charges may be allowed according to the period of delay i-e 50% waiver on one year delay, 100% waiver on delay of two or more years.
- iv. Refund of already deposited delayed charges may not be allowed

### **Decision**

The Board deferred the agenda item and decided that the issue may be linked up with the report of the inquiry committee constituted for seven projects as cost and time overrun.

### <u>Requests of Syed Azam Raza Rizvi ex allottee of apartment no. GF- 03,</u> <u>Block No. 19-D, at G-10/2 Islamabad for waiver of cancellation charges</u>

#### **Background of the case**

The allotment of Syed Azam Raza Rizvi ex-allottee of "D" type apartment no. GF 03, Block No. 19, at G-10/2 Islamabad was cancelled due to non payment of installments by invoking clause 7.3 of the terms and condition of allotment, therefore as per terms and conditions, cancellation chargers @ 10 % of apartment price shall be deducted from the deposited amount. Amount of cancellation charges in the instant case comes to Rs. 350,000/-.

#### **Request of allottee:**

Mrs. Riffat Kazmi mother of alottee has submitted her request for waiver of cancellation charges to the Minister for Housing. The honorable Minister for Housing marked the application to PHA Foundation with remarks "for sympathetic consideration". She has requested that her husband is heart patient and they have to spend huge amount of money on the treatment of her husband. She has further stated that according to the advice of doctors her husband has to undergo another heart operation, and they need huge amount of money and her son who is the ex-allettee of the said apartment is the only earning hand of the family. She has also submitted the medical documents regarding illness of her husband. Therefore she has requested for waiver of cancellation charges.

### The matter is therefore placed before the Board for consideration.

### Decision

The Board decided that a working paper may be prepared and submitted before the Board on the terms and condition of cancellation, so that any such request for waiver may be examined as a uniform Policy.

### <u>Requests of Mrs. Ghulm Sughra ex-allottee of apartment No. TF-16</u> <u>Block No. 18-D, at G-10/2 for waiver of cancellation charges</u>

#### **Background of the case**

The allotment of Ghulam Sughra ex-allottee of "**D**" type apartment no. TF 16, Block No. 18, at G-10/2 Islamabad was cancelled due to non payment of installments by invoking clause 7.3 of the terms and condition of allotment, therefore as per terms and conditions, cancellation chargers @ 10 % of apartment price shall be deducted from the deposited amount. Amount of cancellation charges in the instant case comes to Rs. 335,000/-.

#### **Request of allottee:**

Mrs. Ghulam Sughra has submitted her request for waiver of cancellation charges, she has requested that her husband was heart patient and stay on bed for more then 2 years and eventually died on 21-08-2011, and he was the only soucre of earning of her family, therefore she is unable to pay the installmenst and her apartment was cancelled due to non payment of installemnts. She has also submitted the medical documents regarding illness of her decessed husband. Therefore she has requested that her deposited amount may be refunded to her without 10% of cancellation charges

The matter is therefore placed before the Board for consideration.

### **Decision**

The Board decided that a working paper may be prepared and submitted before the Board on the terms and condition of cancellation, so that any such request for waiver may be examined as a uniform Policy.

### VACANT APARTMENTS, SHOPS AND OFFICES AT LAHORE

Some apartments, shops and offices at Lahore projects (Wafaqi Colony "D" & "E" type, Shabbir Town "B" type, UET shops, Shops at STB & STD are lying vacant. These apartments have been launched by PHA twice but not booked due to very poor response by general public as well as from Federal government employees. Meanwhile due to cost overrun the engineering sections proposed the revised cost of apartments of "D" type and "E" type which is as under:

#### Proposal:

In light of the above it is proposed that the vacant apartment may be re-launch for general public on the revised cost provided by the Engineering/Technical Wing and furthermore marketing cost upto 1 % of the cost, if deemed appropriate, may also be added in the projects before re-launching.

### Decision

The Board approved the revised cost in principal, however, it was decided that for f ffective marketing, some reputed consultant / firm may be engaged as admissible in PEPRA Rule for sale of vacant apartments/shops.

### APPOINTMENT OF CONSULTANT FOR CONSTRUCTION OF MULTI-STORY RESIDENTIAL COMPLEX AT CARLTON HOTEL SITE KARACHI.

Ministry of Housing & Works directed PHA to initiate plan for construction of Commercial-cum-Residential Complex on Carlton Hotel plot Karachi (property owned by the Ministry). The possession of land measuring 3.14 acres was handed over to PHA Foundation. Expression of Interest (EOI) was invited on JV basis which was not materialized. Authority Board in its 29th meeting decided that PHA should launch the project on its own through renowned Marketing Consultant and Construction done as per PPRA Rules/PHA policy in vogue.

In this connection, applications from the Consultants were invited through advertisement in national press dated June 20, 2012. Twenty nine (29) Consultants applied for pre-qualification (List attached).

The services Pakistan Council of Architects & Town Planners (PCATP) were hired for pre-qualification of Consultants as per standard criteria of PEC. PCATP scrutinized and evaluated the pre-qualification documents and furnished the report on November 12, 2012. Following firms are recommended for pre-qualification:-

### DECISION ON REPORT OF THE COMMITTEE ON COST & TIME OVERRUN ON 07 (SEVEN) ONGOING PHA PROJECTS.

This matter was placed before 5th PHA Board meeting held on 27th September 2012 and it was decide that:-

- a) An inquiry Committee headed by Dy. Managing Director PHA Foundation and associated by DG Pak PWD, one Engineering from National Construction and one Engineer from PHA Foundation would examine the two previous inquiry reports and submit their report containing specific recommendations regarding fixing of responsibility and future action.
- b) The Committee would also ascertain and certify that overpayment made to the contractor are due to variation in BOQ's and work on ground commensurate with the payments already made and bills which have been submitted for payment. PHA would take further action on receipt of Inquiry report.
- c) The BoD further directed that keeping in view the miseries faced by the allottees, the PHA Foundation may start the remaining work on the seven projects after completing formalities.
- d) In the 4th BoD meeting, it was decided that FIA would be a part of the Inquiry. However, if any financial embezzlement is detected by Technical Committee, the matter would be referred to FIA for investigation.

2. In the light of above decision, Committee was constituted vide office order No. F.2(27)/2012-Admin-I dated October 22, 2012 with the following mandate:-

a) The mandate of this Inquiry Committee would be to examine the previous two inquiry reports regarding the stalled "7" seven projects. The Committee will submit the report containing specific recommendations and fixing of responsibility. The Committee will also examine the feasibility of work to be done and future payments".

3. National Construction informed that no engineer in available for nomination, at present, in order to participate in the Inquiry Committee. Meanwhile, Dy. Managing Director PHA Foundation also transferred from PHA Foundation.

4. A new Inquiry Committee comprising DG Pak PWD (Chairman), Mr. Qaiser Abbass, SE Pak PWD and Mr. Muhammad Farooq Azam, Dy. Director Engineering has been reconstituted vide letter even No dated November 14, 2012 with the same mandate as was given to previous Committee.

5. It is not out of place to mention here that para (b) & (d) of the approval of BoD is not made part of the mandate of the committee.

Decision

Director General, Pak-PWD gave a detailed presentation on cost & time overrun on 07 stalled PHA Projects. Various options of resumption of work on the projects and arrangement for finances required thereof were discussed in depth. Matter regarding fixing of responsibility was also deliberated upon. It was decided that final decision will be taken on receipt of INQUIRY REPORT from DG Pak-PWD. DG Pak-PWD assured that report would be submitted by December 31st 2012.

## ISSUANCE OF LETTER OF COMMENCEMENT OF CONSTRUCTION WORK AT KURRI ROAD PROJECT

Reference 4th Board meeting held on July 19, 2012, letters of acceptance were issued on July 24, 2012 to the contractors for award of work at Kurri Road Project as below:

M/S Abdul Majeed & Cp.
M/S Techno (Pvt) Ltd.
M/S National Construction
M/S Abdul Majeed & Co.

Later, Ex-Director (Engineering) and M/S Techno (Pvt) Ltd. filed cases in Islamabad High Court. Resultantly, Islamabad High Court suspended the operation on the 4th Board meeting decisions.

Now, the stay orders issued in both cases have been vacated and there is no bar on PHA Foundation to issue letter of commencement to the contractors to start the work on the project site.

A summary was forwarded to Prime Minister of Pakistan regarding decision for allotment of plot or houses in the housing scheme has conveyed Ministry of Housing & Works vide letter No.F.2 (3)2011-Works dated 12-12-2012 that the Prime Minister of Pakistan has not approved the proposal and further directed that funds received from allottees be spent exclusively for the purpose of construction of houses, development of said scheme.

The matter is being placed before the Board for further decision.

### **Decision**

It was pointed out that 02 out of 03 firms to whom letter of acceptance for the housing units have been issued are involved in cost & time overrup of 04 stalled PHA projects. Since, letter of acceptance has already been issued by the Ex-MD, PHA, hence, cancellation of the same would attract unnecessary litigation. Therefore, in order to avoid unnecessary litigation and delay in execution of Kurri Housing Scheme, it was decided that the contract may be signed. However, to safeguard the PHA interest, a bank guarantee may also be obtained for performance criteria and mobilization advance.

### ADOPTION OF PAK-PWD CODE

To provide shelter to shelter less people on affordable cost and to meet the target Pakistan Housing Authority Foundation acted as executing organization but without having its own code.

In past PHA kept on assigning its engineering job to consultants but this experience of reliability on the mercy of consultant has not been found satisfactory. Resultantly, project started under Prime Minister Directive in 2008 suffered a huge cost and time over run.

In view of stated position it has been felt necessary that PHA engineering wing must be strengthened and a standard engineering code/ practice be adopted. Further, Pak. PWD is its sister organization of PHA under the Ministry of Housing & Works.

It is proposed that Pak PWD code be adopted in PHA.

## **Decision**

Keeping in view, the anomalous situation cropped up due to nonexistence of PHA code or any other standard code of practice, the Board unanimously approved the adoption of Pak-PWD code with immediate effect.

### PROPOSAL FOR POSSIBLE BENEFIT TO PHA EMPLOYEES

On May 18, 1999, the Prime Minister Housing Authority (PMHA) was established under a Cabinet Resolution in the Prime Minister's Secretariat for implementation of a project of construction of 500,000 housing units. Proposal for granting autonomous status was initiated on September 27, 2010 after obtaining views of all the stakeholders. Federal Cabinet accorded approval in principle on October 6, 2010. PHA Board of Directors in a meeting held on December 17, 2010 approved the confirmation of PHA as Public Limited Company. PHDCL already stood registered with SECP since July 13, 1999 and this dormant company has been renamed as PHA-Foundation (Pvt) Ltd in February 2011.

PHA-F appoints regular staff up to BS-18, however the top management are hired through deputation. Gross salary is been paid to the regular staff as per basic pay scale. Currently GP Fund/CP Funds is not deducted from the salary of regular staff. No benefit of Pension/commutation, GP Fund, advances (HBA, Car advance Motorcycle advance), is extended to regular employees of PHA-F.

#### Proposal for Possible Benefit to PHA-F Employees

- PHA being cash strapped Organization cannot do much for its employees.
- However looking at the example of other foundation like PEMRA, PTA ,OPF etc. during service and after Retirement benefits need to be ensured for the Employees.
- **State Life Group Insurance** provides a solution to this without putting any financial impact on PHA-F.
